Using your voice to advocate for the BBA

Your MP was elected to represent their constituents in Parliament. That includes you!

Showing MPs first-hand how businesses are operating within their constituency, and already taking ownership of their social and environmental impact, will help to build the case for the Better Business Act.

You don't need to be a policy expert to host your MP and convince them of the importance of the BBA. Remember, many will not be specialists, and you are the expert on your own business.





Local Visibility

A visit from an MP is a good opportunity to generate local press coverage, and cement awareness of the Better Business Act within your community.

The BBA Campaign Team, who can be contacted at advocacy@betterbusinessact.org, can support you to identify local media opportunities that will boost your business' visibility and bolster the campaign.

Publicising a visit in the local press is a win-win. MPs will be keen to be seen taking an active interest in businesses in their constituency and you are able to boost your profile in the community.





Capturing the moment


Editors of local newspapers like to see images of a politician participating in an activity – such as pouring a pint! Alternatively, a group photograph with all staff is equally effective.

These are suggestions but please do use your own words to explain why you care about the Better Business Act. MPs receive hundreds of messages a day and are more likely to respond to personalised correspondence.



FAQs

Who is my MP?

Search constituencies and MPs in the United Kingdom by name, postcode or location <u>here</u>.

How do I get in touch?

Searching using the above link will take you to a page listing your MP's contact details. Make sure you contact them via their Constituency Office.

Should I write to the MP who represents my home or my business?

You should ensure that you are inviting the MP who represents the particular site where you want to host the visit.

How do I know who else in my area is supportive of the BBA?

It can be daunting hosting a visit alone if it's your first time. Equally, being able to offer an MP an opportunity to engage with several local business in a compressed format can be a compelling proposition. Email us at advocacy@betterbusinessact.org and we can look at putting you in touch.

How should I follow up?

MPs will appreciate the message and it will ensure that a good relationship is maintained. Email us and we can support you in shaping an appropriate follow-up with clear asks. What these asks are will depend on how your visit went and could range from asking a question in the Commons to convening a further event on the BBA.
